Example of Speech against a resolution

Against China

Over the past two years China has increasingly intervened in the affairs of neighbouring autonomous regions including the human rights abuses to the Uighur Muslim minority placing them in so called 're education camps' and the brutal crack down on the protests in Hong Kong (violating freedom to practice religion and freedom of speech). The military invasion of Taiwan has crossed all lines and is comparable with Hitler's invasions of Eastern European countries in the 20th century. The delegate of the UK condemns China's actions and urges all member states of this honourable committee to boycott the people's republic of China and impose sanctions as an act of punishment for transgressing international law.

Does the delegate of China not recognise that by invading Taiwan have breached many treaties and have acted in a way that promotes modern day colonialism?

Does the delegate of Russia not recognise that backing Bashar Al Assad and supplying military support to such a dictator destabilises an ever so turbulent region and displaces more people and results in more civilian deaths?



Amendments

- Amendments are changes to a resolution that a delegation can submit
- Amendments are changes you want to make to the resolution. This could be removing parts of a clause/whole clause, adding a new clause or adding onto a clause.
- You must submit all amendments before... in order for them to be considered
